OLD BUSINESS (Applicants Present Submissions)

1. Youmans Road LLC – Maria Gurin (Great View Terrace) – applicant is requesting a Swift Road Water District extension to service two (2) building lots located on the south side of Great View Terrace. The parcel to be subdivided is identified as New Scotland tax parcel 72.-03-40.1 and will result in a proposed three (3) lot minor subdivision. **Update from Building Department (JC).**

2. John Romeo / Tate Subdivision (362 New Scotland South Road) – applicant is requesting a Heldervale Water District extension to provide water to a total of four (4) parcels (one existing lot plus three (3) proposed additional lots). The parcel to be subdivided is identified as New Scotland tax parcel 84.-2-47.

3. John Peck, Trustee (120 Lower Flat Rock Road) -- applicant is requesting a Clarksville Water District extension to provide taps to two parcels of a three parcel subdivision of a 72 acre parcel. The parcel to be subdivided is identified as New Scotland tax parcel 106.-4 -41). The taps would service Lot 1 and Lot 3. **Update from Building Department (JC) and DPW Commissioner (WW)**
