## TOWN OF NEW SCOTLAND NOTICE OF RECEIPT OF TAX ROLL AND WARRANT

**TAKE NOTICE**, that I Diane Deschenes, the undersigned Collector of Taxes of the Town of New Scotland, County of Albany and State of New York, have duly received the tax roll and warrant for the collection of taxes within the Town of New Scotland for the year 2010, and that I will collect at 2029 New Scotland Road, Slingerlands NY in said Town of New Scotland from 8:30 A.M. to 4 P.M. each day, except Saturdays, Sundays and holidays for the purpose of receiving taxes on the said roll.

**TAKE FURTHER NOTICE**, that taxes may be paid on or before January 31<sup>st</sup> without interest. On all taxes received after such date, there shall be added interest 1% if paid on or before February 28<sup>th</sup> and an additional 1% for each additional month or fraction thereof thereafter until such taxes are paid or until the return of unpaid taxes to the county treasurer pursuant to law.

**TAKE FURTHER NOTICE**, that pursuant to the provision of the law the tax roll of the Town of New Scotland will be returned to the county Treasurer of the County of Albany on the 1<sup>st</sup> day of April, 2010.
